Anticipated outcomes of the COPS Hiring Program awards include engagement in planned community partnerships, implementation of projects to analyze and assess problems, implementation of changes to personnel and agency management in support of community policing, and increased capacity of agency to engage in community policing activities.

a crisis intervention team as an employee of a law enforcement agency or under a legal agreement with a law enforcement agency.

The goal is to equip K–12 students, teachers, and staff with tools to recognize, respond to, and prevent acts of violence.

Funding can be used to develop and/or enhance support services for children exposed to violence to reduce the adverse impact of violence on youth,

families, and communities, and to help family-serving organizations better recognize and help families at risk for exposure to violence; and support multidisciplinary or coalition-building efforts to enhance communities' responses to CEV.
